**REGULATIONS**  
**THE WILDLIFE CONSERVATION (AUTHORISED OFFICERS) (IDENTITY CARDS)**  
**REGULATIONS**

(Section 94)

G.N. No. 270 of 1974

**1.** These Regulations may be cited as the Wildlife Conservation (Authorised Officers) (Identify Cards) Regulations.

**2.** Every authorised officer, other than a police officer, and every person appointed by the Director under the provisions of section 2 of the Wildlife Conservation Act <sup>i\*</sup>, to exercise the functions of an authorised officer shall carry an identity card in the form prescribed in the Schedule to these Regulations while exercising the functions of an authorised officer.

**3.** An authorised Officer shall, upon ceasing to be an authorised officer, surrender his identify card to the Director.

**4.** Any authorised officer who loses his identity card or whose identity card is destroyed or defaced shall as soon as possible, report the loss, destruction or, as the case may be, defacement to the Director who may issue a fresh card.

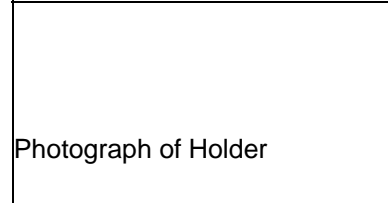
**5.** The Director shall maintain a register of all authorised officers in which shall be recorded the name of the officer and the particulars of the identity card issued to such authorised officer.
