REGULATIONS
THE WILDLIFE CONSERVATION (PRESIDENT'S LICENCE) REGULATIONS

(Section 94)

G.N. No. 273 of 1974

1. The Regulations may be cited as the Wildlife Conservation (President's Licence) Regulations, and shall come into operation on the date of the commencement of the Wildlife Conservation Act^{i*}.

2. A President's licence under section 44 of the Wildlife Conservation Act, shall be in the form prescribed in the Schedule to these Regulations.

3. Any person who contravenes any condition annexed to a President's licence commits an offence and shall on conviction is liable to a fine not exceeding fifteen thousand shillings or to a term of imprisonment not exceeding three years or to both that fine and imprisonment.
